In consideration of participating in the Sgt. Bertram Memorial 5K-9, I represent that I understand the nature of the 5K and that I and/or my minor child and/or my dog(s) am qualified, in good health and in proper physical condition to participate in such activities. I further acknowledge that the activity will be conducted over public roads and facilities open to the public during the activity and upon which traffic hazards are to be expected. I acknowledge that if I and/or my minor child believe event conditions are unsafe, I and/or my minor child and/or my dog(s) will immediately discontinue participation in the activity.

I fully understand that the Sgt. Bertram Memorial 5K-9 event involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time: and I fully accept and assume all such risks and all responsibility for losses, costs and damages I and/or my minor child and/or my dog(s) incur as a result of my and/or minor child's and/or my dog(s) participation in the activity.

I hereby release, discharge and covenant not to sue the City of Charlestown, Charlestown Police Department, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers and if applicable, owners and lessors of premises on which the activity takes place, (each considered one of the "releasees" herein), from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my and/or minor child and/or my dog(s) behalf, makes a claim against any of the "releasees", I will indemnify, save and hold harmless each of the "releasees" from any loss liability, damage, or cost which may be incurred as the result of such claim.

I fully understand that other participants in the Sgt. Bertram Memorial 5K-9 will have dogs and that dogs are animals and that animals can be unpredictable at times. I understand that by running with or along side or by participating in this event with dogs I may be bitten, scratched, tripped and/or injured in some way and that if I, my minor child and/or my dog are bitten, scratched, tripped or injured in any way the City of Charlestown, Charlestown Police Department nor it's respective administrators, employees, volunteers, or agents are liable or responsible for such injury.

I have read this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement and Parental Consent Agreement and understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
