

ORDINANCE NO. 1969-12

AN ORDINANCE PROVIDING FOR THE REGULATION OF PERSONS, FIRMS OR CORPORATIONS SELLING OR SOLICITING FROM DOOR TO DOOR WITHIN THE CORPORATE LIMITS OF THE CITY OF CHARLESTOWN, INDIANA, AND PROVIDING FOR PENALTY FOR THE VIOLATION THEREOF.

WHEREAS, it is within the best interests of the citizens of the City of Charlestown, Indiana, that door to door salesmen shall apply and register with said Municipal Corporation and upon successful application procure a license before selling or soliciting within the Corporate Limits of the said City of Charlestown, Indiana:

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF CHARLESTOWN, INDIANA, THAT:

SECTION I. Before any person, firm, or corporation shall solicit or sell or in any manner peddle from door to door within the Corporate Limits of the City of Charlestown, Indiana, each person representing a firm or corporation shall first apply to the said City of Charlestown, Indiana, at the office of the Clerk-Treasurer for license to so do, and shall pay a license fee in the sum of TEN (\$10.00) DOLLARS for each and every day such soliciting, selling or peddling shall continue within said City.

SECTION II. Each person representing self, a firm or corporation wishing to engage in solicitation, selling or peddling within said City may, at his or their option, procure a yearly license for an annual fee of TWENTY-FIVE (\$25.00) DOLLARS, said yearly license to be issued on a calendar year basis, from January 1, to December 31 of the year in which application is made.

Annual Licenses issued subsequent to January 1 of any calendar year shall be valid from the date of issuance to December 31 of the year in which application is made, and shall not be issued for a sum less than a full annual fee in the same manner as though application and issuance would have occurred on January 1,

SECTION III. The penalty for violation of this ordinance shall be a fine or not less than TEN (10.00) DOLLARS nor more than TWENTY-FIVE (\$25.00) DOLLARS.

Each offense occurring shall be deemed a separate offense for the purpose of assessing penalties herein provided.
